THEREFORE BE IT RESOLVED that the California Democratic Party will always uphold a person's right to privacy and reproductive health including abortion and that we proudly state that California is a Reproductive Freedom state for all, and

THEREFORE BE IT FURTHER RESOLVED that the California Democratic Party strongly encourage the State of California and people of conscience to withhold doing business with States passing laws attacking Reproductive Freedom and that copy of this resolution be sent to the Governor, the Pro Tem of the Senate and the Speaker of the Assembly.

1 WHEREAS on March 28, the Sultan of Brunei, the owner of the Bel Air Hotel and the Beverly Hills 2 Hotel, directed that gays, lesbians and transgender individuals in his country should be put to 3 death by stoning, joining Saudi Arabia, Oman, Kuwait, the United Arab Emirates, and Malaysia as 4 the only countries in the world that criminalize gender expression and joining the over 25 5 countries that criminalize same-sex relations:

7 WHEREAS Human Rights Watch has noted that over 25 countries use fundamentalist 8 interpretations of religious law to criminalize same sex-relations, including Iran and Saudi Arabia 9 where such activity can and has been penalized by death (Iran leads the world in the execution of gay men), or prison sentences ranging from two months in prison in Somalia to over ten years in 10 prison in Sierra Leone, Malawi, the Palestinian Territories, Kiribati, Pakistan, Malaysia and 11 12 Myanmar, resulting in a culture of violence and repression against LGBT individuals encouraged 13 by or tacitly tolerated the government; and

WHEREAS the California Democratic Party has previously opposed the killings of and criminalization of gays, lesbians and transgender persons in Russia, Chechnya, and Uganda.

Decriminalization of Pregnancy Losses in California

Resolution Of The California Democratic Party In Support Of Full Parity For Mental Health Patients And Clinicians At Kaiser Permanente

WHEREAS mental illness is among the most common health problems faced by Californians, with nearly 1 in 6 California adults experiencing a mental illness of some kind and more than half of Californians believing that most people suffering with mental health conditions do not get the help they need; and

WHEREAS Kaiser Permanente (Kaiser), California's largest health insurer and provider of healthcare services with more than 8.8 million covered lives statewide, was fined \$4 million by the California Department of Managed Health Care in 2013 for violations of California's Mental Health Parity Act and standards for timely access to care, was cited for ongoing violations in two follow-up investigations, and is currently under a state-ordered monitoring program scheduled to continue until 2020; and

WHEREAS despite repeated claims to the contrary, Kaiser has barely increased its ratio of 1 fulltime mental health clinician to every 3,000 plan members, and understaffing remains so severe that more than 60,000 California Kaiser patients annually are being referred to outside therapists who often cannot adequately coordinate their care with other Kaiser health professionals, thereby denying patients the integration of health care services that Kaiser promises; now

THEREFORE BE IT RESOLVED that the California Democratic Party strongly supports the establishment of full parity for mental health patients and clinicians at Kaiser Permanente by boosting clinician staffing to levels sufficient to ensure timely access to appropriate care, with caseloads of no more than one new intake visit for every five return appointments, patient wait times of no more than ten business days for return appointments unless directed by the treating clinician, and third-party resolution of disputes regarding staffing standards; and

BE IT FURTHER RESOLVED; Kaiser Permanente strictly limit and ultimately phase out the outsourcing of mental health services so as to ensure that Kaiser's mental health patients receive the full benefits of reliable, accountable, integrated mental and physical health care across the full spectrum of their treatment; and provide Kaiser's mental health clinicians with the same raises and benefits enjoyed by all other members of Kaiser's unionized workforce throughout the State of California, as required to address staff shortages and recruit and retain a stable and experienced workforce.

RESOLUTION TO SUPPORT INITIATIVE AND REFERENDUM PROCESS REFORM

Ending Physical/Corporal Punishment of Children

WHEREAS there is overwhelming evidence that spanking is harmful to children and families as it increases aggression and violence long term, impacts normal brain development, is considered an Adverse Childhood Experience (ACE) that can lead to many poor health and social outcomes, and is ineffective in teaching responsibility and self-control, and the rationale for spanking is the same that was accepted for men hitting women in recent history; and

WHEREAS there is consensus among international and national human rights advocates that spanking violates children's human rights, and at least seven human rights treaties include physical violence against children under the guise of discipline; the United Nations has said unequivocally that corporal punishment is a form of violence against children, and 54 countries around the world—a majority—have already banned all physical punishment, and California leads the nation on progress for our most vulnerable populations, as well as for respecting science; and

WHEREAS the American Academy of Pediatrics, American Psychological Association, American Association of Child & Adolescent Psychiatry, Centers for Disease Control and Prevention, National Association of Pediatric Nurse Practitioners, and dozens of other organizations have advocated banning all physical punishment as a public health issue, and researchers have concluded that spanking is a form of violence against children that should no longer be a part of American childrearing;

THEREFORE BE IT RESOLVED that the California Democratic Party is opposed to any physical/corporal punishment in any educational, detention, childcare facility or institution, or any other setting; and

BE IT FURTHER RESOLVED that the California Democratic Party supports ending all physical/corporal punishment of any person of any age in any setting and supports strong educational programs, parenting classes, evidence-supported early intervention programs during pregnancy and well-child visits, and other programs and policies that reduce spanking.
